



BUR elaboration and ICA process ^a



CMNUCC 2/CP.17

- Mexico presented its first BUR on October 23th, 2015.
- The technical analysis (ICAa) was conducted from 29th February to 4th March 2016 in Bonn, Germany.
- It was reviewed by the roster of experts (TTEb) of the Convention with representatives of Chile, Cuba, Italy, Spain, Paraguay and Perú.

- •In April 2016 a first round of questions on the BUR was answered and the final TTE report was received on May 30th (public document)
- •The BUR was presented in November 2016, during COP22 at the facilitating workshop for the exchange of views (Marrakech) (FSV c)

Leanings and changes in reporting future BURs?



- •Balance on TTE and ICA recommendations relevant to identify next BUR and improvement opportunities (deep screening).
- •Information flux and data availability are the greatest benefits.
- •Technical team experience as main resource for BUR and ICA process.
- Necessary to be trained as part of the team on BUR reviewers and specific methodologies of analysis.



ICA process is a great opportunity to enhance transparency but BUR guidelines are general and some times not enought clear about criteria to organice or present information.

Some examples to show how to do it should be provided.



Recommendations for other countries

- Legal framework development as main step of BUR integration process.
- Strong institutional arrangements provides the basis for any step of BUR or mitigation policy.
- Technical capacity building to facilitate BUR integration and review.
- Transparency is aligned to financing support.
